## Rider Waiver Form

#### Please Read and Sign:

You **AGREE** to be bound by the following to participate in the 2021 “Ride-to-Remember IX”:

- \* I agree that my level of fitness is appropriate to participate in this event. I have no physical or medical condition(s), which would endanger myself or others if I participate in this event, or would interfere with my ability to participate in this event. I assume all responsibility for my health relative to the ride.
- \* I agree that my bicycle is in safe condition. I accept responsibility for the condition of my bicycle and my riding equipment. I will ride wearing an approved helmet of my choosing. I assume all responsibility for my helmet and its functionality.
- \* I agree **not** to wear headphones or use a mobile phone while biking in this event.
- \* I agree to ride safely, signal my movements, be alert to my surroundings, stay to the right when riding and pass on the left. I am familiar with and agree to be bound by the bicycle riders rules of the road in MA. I will obey all orders given to me by the Official Ride Marshals in the Ride-to-Remember.
- \* I agree to obey all the rules given to me by the Ride-to-Remember. If I fail to comply with all the rules I will be asked to leave the ride and may forfeit my right to participate in subsequent rides.
- \* I understand that bicycling involves risks, these risks include but are not limited to, loss of personal property, bodily injury to myself and death.
- \* I understand the risk associated with public events and COVID 19 and I understand that bike riding in a group may promote the spread of the virus. I am fully vaccinated or I will have a negative COVID 19 test within 10 days of the ride. I assume the risk of contracting COVID 19.

#### Assumption of the Risk.

**I personally assume any and all risks associated with my participation in this event, including the risk of contracting COVID 19. I hereby release, absolve, indemnify and hold harmless the “Ride-to-Remember”, Springfield Police Department, City of Springfield, all Ride-to-Remember Board members and Officers, all other riders, all participants, all volunteers, Directors, sponsors, ride marshals, and all assisting Police Officers and Firefighters from any manner of liability, claims for damages or causes for action relative to any injury to me or my family or loss of personal property suffered by me as a result of my sole decision to participate in the 2021 ride.**

***GENERAL RELEASE*** *In consideration of the right to participate in the Ride to Remember, Inc. charitable fundraising event, I, the undersigned, being fully informed, hereby release, acquit and forever discharge Ride to Remember, Inc. and its officers, directors, volunteers and affiliates from any and all personal injury claim and/or personal property damage claim of any nature or magnitude, which I or my heirs, assigns and legal representatives may have as a result of my voluntary participation in the Ride to Remember, Inc. charitable event as a rider, volunteer or spectator on October 9, 2021.*

**I HAVE READ THIS AGREEMENT and I FULLY UNDERSTAND IT. I UNDERSTAND THAT I HAVE RELEASED AND GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY WITHOUT ANY INDUCEMENT OR PROMISE OF ANY NATURE AND I INTEND THIS RELEASE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF MY RIGHT TO BRING A CLAIM AND THE LIABILITY OF RIDE TO REMEMBER, INC. TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD INVALID FOR ANY REASON, THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.**
